INTENDED USE

The DeRoyal® Wrist Splint is intended to provide support, compression and alignment to the wrist.

INDICATIONS

De Quervain's Syndrome; Scaphoid injuries; Carpometacarpal instabilities; Metacarpal fractures; Post cast healing; Gamekeeper's thumb; Cumulative trauma iniuries

\CAUTIONS


- A physician or properly licensed practitioner (a "prescriber") who is familiar with the use and purpose of this brace must fit it to the user. The prescriber has a duty to provide wearing instructions and risks related to the use of this brace to other healthcare practitioners treating the users and the users themselves, including duration of use. The instructions provided in this sheet do not supersede hospital protocol or direct orders of the prescriber.
- Use only as directed by medical professional. Prolonged usage can result in muscle atrophy in the user. The user may require (1) a weaning period from the brace to build muscle strength (2) regular physical therapy exercises to maintain the strength of the wrist/arm (3) a limitation on duration of use or (4) some combination of these.
- Inspect brace for damaged or missing components before use.
- Discontinue use and consult your prescriber if the brace or its components break or become damaged.
- Inspect the fit of the brace on the patient to ensure fit is proper. DO NOT OVERTIGHTEN. Check regularly to ensure circulation is not compromised.
- Consult your prescriber immediately if you experience sensation changes, unusual reactions, swelling or increased pain while using this brace. Discontinue use if pressure injuries develop.
- Take special care if the user is diabetic or has poor circulation as these users may have



decreased skin sensitivity and are at greater risk for poor peripheral circulation and pressure injuries.

INSTRUCTIONS FOR USE

1. Open dynamic, hand and thumb closure to expose the interior portion of the splint.



- **3.** Position splint with palmar side of the splint below palmar crease. Readiust as necessary.
- Adjust metal wrist and thumb stavs for proper positioning and fit.
- Wrap thumb strap around thumb for snug but comfortable fit.
- **6.** Next, attach the dynamic closure on opposite side of wrist using hook attachment and attach hand closure to desired level of comfort.
- Once dynamic and hand closure is secured, pull and stretch the dynamic tab to desired level of comfort and secure on opposite side.











UNIVERSAL ADJUSTMENT

- 1. Remove palmar (curved) stay and dorsal (flat) stay from their pockets and switch them into the opposite pocket. The splint is now set up to wear on the opposite hand. **NOTE:** Stay pockets are held closed by hook dots.
- 2. Continue with steps 2-7 for fitting.







CARE INSTRUCTIONS

Remove the stays before washing. Hand wash in lukewarm water with mild detergent. Air dry completely prior to re-application.
