



- 2. To secure the cuffs on the patient, open the cuff by releasing the guick release buckle and hook and loop, utilizing the small white



tabs. Wrap the cuff around the patient's wrist or ankle with the soft foam side touching the patient's skin, then follow with the loop side securing it to the hook. Attach the other hook tab to the loop.





3. To secure the quick release buckle around the cuff, insert the male end into the female end of the buckle. Pull excess strap to tighten.
